### Notes:

1. Athletes will trial in their provinces on the 19<sup>th</sup> and 20<sup>th</sup> March 2016.
2. Provinces will trial for JM4-; JM4+; JM2X, JM2-, JW2-, JW2x and JW4x-.
3. Selected boats will progress to the South African National Championships to be held at Roodeplaat Dam on the 30<sup>th</sup> April and 1<sup>st</sup> May 2016 where they will compete against the other provinces.
4. The fastest crews will progress to the National Selection regatta to be held at Roodeplaat Dam on the 11<sup>th</sup> May 2016.
5. Qualification for selection will require the progressed crews to achieve a prognostic time that is within 3% of the fastest time of the day.
6. All athlete's coaches are invited to attend the provincial selections. Coach selections for crews will be made provincially.
